Dear parent

During May 2021, students in Years 3, 5, 7 and 9 will sit NAPLAN. The schedule for the tests is as follows:

Tuesday 11 May	Wednesday 12 May	Thursday 13 May
Language Conventions test	Reading test	Numeracy test
(spelling, grammar and punctuation)		
Writing test		

On Friday 14 May – a 'catch-up' day is scheduled for students who missed a test or were absent on a test day.

Students may be exempt from the NAPLAN test if they:

- are from a language background other than English, have arrived from overseas and have been attending school in Australia for less than a year before the test; or
- have significant intellectual disability and/or significant co-existing conditions which severely limit their capacity to participate in the tests.

Students may be withdrawn from NAPLAN by their parent or carer after consultation with the school principal. To withdraw your child from NAPLAN, a parent or carer consent form must be signed.

All other students are expected to participate in the tests.

Disability adjustments which reflect the student's normal level of support in the classroom may be provided. Alternative format test materials are available to meet the needs of individual students (e.g. braille, large print, black and white test material or the electronic test). Access to disability adjustments or exemption from the tests must be discussed with the school principal and a parent or carer consent form must be signed.

Please make an appointment with the principal if you need to discuss your child's participation in NAPLAN.
